Holiday for Small Passenger Vehicles" (Jiao Gong Lu Ming Dian [2020] No.20) (《關於做好 2020年春節假期免收小型客車通行費有關工作的通知》(交公路明電[2020]20號)), "Notice on the Extension of the Toll-Free Period for Small Passenger Vehicles during the 2020 Spring Festival Holiday" (Guo Ban Fa Ming Dian [2020] No. 1) (《關於延長2020年春節假 期小型客車免費通行時段的通知》(國辦發明電[2020]1號)) and "Notice on the Extension of the Toll-free Period for Small Passenger Vehicles on Toll Roads during the Spring Festival Holiday" (Jiao Gong Lu Ming Dian [2020] No.38) (《關於延長春節假期收費公路免收小型 客車通行費時段的通知》(交公路明電[2020]38號)), the toll-free period for small passenger vehicles on all toll roads in the PRC with respect to 2020 Spring Festival Holiday commenced from 0:00 a.m. on 24 January 2020 to 24:00 on 8 February 2020. According to the "Notice in relation to the Toll Fees Exemption for Vehicles on Toll Roads during the Prevention and Control Period of the Coronavirus Pandemic" (Jiao Gong Lu Ming Dian [2020] No. 62)(《關 於新冠肺炎疫情防控期間免收收費公路車輛通行費的通知》(交公路明電[2020]62號)), toll fee exemption for vehicles on all toll roads in the PRC should be implemented from 0:00 a.m. on 17 February 2020 to the end of the prevention and control measures over the coronavirus pandemic. According to the "Notice on Resumption of Toll Collection on Toll Roads" (No.25 in 2020) (《關於恢復收費公路收費的公告》(2020年第25號)), the collection of toll on legally approved toll roads resumes, effective from 0:00 a.m. on 6 May 2020. All the projects of the Group have resumed the normal toll collection.
- 2. The toll revenue referred to in this announcement includes value-added tax and is rounded to the nearest RMB1,000.
