**INTRODUCTION**

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the AGM relating to: (i) the re-election of two Directors who shall retire from office by rotation at the AGM; and (ii) the proposed Issue Mandate and the proposed Repurchase Mandate. The notice of AGM is also set out on pages 11 to 14 of this circular.

### RE-ELECTION OF DIRECTORS

Pursuant to Bye-Law 84, at each annual general meeting, one-third of the relevant number of Directors (or, if their number is not a multiple of three, the number nearest to but not greater than one-third) shall retire from office by rotation in each year. As such, Ms. Wong Miu Ting, Ivy and Mr. Wong Kui Fai shall retire from office and, being eligible, have offered themselves for re-election at the AGM. Subject to the Shareholders' approval at the AGM, Ms. Wong Miu Ting, Ivy and Mr. Wong Kui Fai will retain as independent non-executive Directors.

At the AGM, separate ordinary resolutions will be proposed for re-election of Ms. Wong Miu Ting, Ivy and Mr. Wong Kui Fai as Directors.

Details of the two Directors proposed to be re-elected at the AGM are set out in Appendix I to this circular.

### RENEWAL OF GENERAL MANDATE TO ISSUE SHARES

An ordinary resolution will be proposed at the AGM to give the Directors a general and unconditional mandate to allot, issue and deal with new Shares with an aggregate nominal amount not exceeding 20% of the issued share capital of the Company as at the date of passing the resolution until the earlier of (i) the conclusion of the next annual general meeting of the Company following the passing of the resolution; and (ii) the date on which the ordinary resolution is revoked or varied by the Shareholders in a general meeting of the Company.

At the annual general meeting of the Company held on 26 August 2013, the Directors were granted a general mandate to allot, issue and deal with new Shares up to 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of such meeting. As at the date of the aforesaid annual general meeting, 151,404,130 Shares were in issue and accordingly, a maximum of 30,280,826 Shares could be issued under the previous general mandate. Such mandate has not been utilized as at the Latest Practicable Date and will lapse at the conclusion of the forthcoming AGM (assuming such mandate remains unutilized up to the date of the AGM). Accordingly, an ordinary resolution will be proposed by the Directors at the forthcoming AGM for the renewal of the Issue Mandate.

If the Issue Mandate is granted together with the Repurchase Mandate, a separate ordinary resolution will be proposed to increase the number of Shares which may be allotted and issued under the Issue Mandate by the aggregate number of Shares repurchased by the Company under the Repurchase Mandate. The Company does not have any present intention to exercise the Issue Mandate (if granted at the AGM).

Subject to the approval of the Shareholders for the renewal of the Issue Mandate, and assuming that no Shares will be issued or repurchased by the Company after the Latest Practicable Date up to the date of the AGM, the Shares in issue as at the date of the AGM would be 151,404,130 Shares, which means that under the Issue Mandate (as renewed) the Directors would be authorised to allot and issue a maximum of 30,280,826 Shares (not taking into account the extension of the Issue Mandate to add the number of Shares repurchased by the Company under the Repurchase Mandate) if the Issue Mandate is renewed.

### RENEWAL OF GENERAL MANDATE TO REPURCHASE SHARES

An ordinary resolution will be proposed at the AGM to give the Directors a general and unconditional mandate to repurchase Shares with an aggregate nominal amount not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing the resolution until the earlier of (i) the conclusion of the next annual general meeting of the Company following the passing of the resolution; and (ii) the date on which the ordinary resolution is revoked or varied by the Shareholders in a general meeting of the Company.

At the annual general meeting of the Company held on 26 August 2013, the Directors were granted a general mandate to repurchase Shares on the Stock Exchange up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company. As at the date of the aforesaid annual general meeting, 151,404,130 Shares were in issue and accordingly, a maximum of 15,140,413 Shares could be repurchased under the previous general mandate. Such mandate has not been utilized as at the Latest Practicable Date and will lapse at the conclusion of the forthcoming AGM (assuming such mandate remains unutilized up to the date of the AGM). Accordingly, an ordinary resolution will be proposed by the Directors at the forthcoming AGM for the renewal of the Repurchase Mandate.

Subject to the approval of the Shareholders for the renewal of the Repurchase Mandate, and assuming that no Shares will be issued or repurchased by the Company after the Latest Practicable Date up to the date of the AGM, the Shares in issue as at the date of the AGM would be 151,404,130 Shares, which means that the Company would be allowed to repurchase up to a maximum of 15,140,413 Shares under the Repurchase Mandate if renewed.

The Company does not have any present intention to exercise the Repurchase Mandate (if granted at the AGM). Repurchases will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole. Considering the rapid changes in market conditions, the Repurchase Mandate can provide more flexibility to the Company to enhance the net asset value of the Company and/or its earnings per Share. An explanatory statement containing information relating to the Repurchase Mandate as required under the Listing Rules is set out in Appendix II to this circular.

### AGM

A notice convening the AGM with the resolutions to be proposed thereat is set out on pages 11 to 14 of this circular. Whether or not the Shareholders intend to attend the meeting, or any adjournment thereof, they are requested to complete the accompanying form of proxy and return it to the Company's branch share registrar in Hong Kong, Tricor Tengis Limited at Level 22, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong as soon as practicable and in any event not later than 48 hours before the time of the meeting, or any adjournment thereof. Completion and return of the form of proxy will not preclude the Shareholders from attending and voting in person at the meeting, or any adjournment thereof, should they wish to do so.

### VOTING BY WAY OF A POLL AT THE AGM

Pursuant to Rule 13.39(4) of the Listing Rules, all votes of the Shareholders in general meetings must be taken by way of a poll. The chairman of the AGM will therefore demand a poll on each of the resolutions to be proposed at the AGM using his powers envisaged under Bye-law 66 of the Bye-laws. The chairman of the AGM will explain at the commencement of the AGM the procedures for conducting a poll. Under Bye-Law 70, in the case of an equality of votes, the chairman of such meeting shall be entitled to a second or casting vote in addition to any other vote he/she may have. After the conclusion of the AGM, the results of the poll will be announced as soon as practicable in accordance with Rule 13.39(5) of the Listing Rules.

No Shareholder is required to abstain from voting on the resolutions to be proposed at the meeting.

### RECOMMENDATION

The Directors are of the opinion that (i) the re-election of retiring Directors and (ii) the renewal of the Issue Mandate and the Repurchase Mandate, are in the interests of the Company and its Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of all resolutions to be proposed at the AGM.

### RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that, to the best of their knowledge and belief: (i) the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive; (ii) there are no other matters the omission of which would make any statement herein or this circular misleading; and (iii) all opinions expressed in this circular have been arrived at after due and careful consideration and are formed on bases and assumptions that are fair and reasonable.

The English text of this circular and the accompanying proxy form shall prevail over the Chinese text in case of inconsistency.

*Pursuant to the disclosure requirements stipulated by the Listing Rules, the details of the Directors proposed to be re-elected at the AGM are set out below:*

**Ms. Wong Miu Ting, Ivy**, aged 52, is an independent non-executive Director. She is presently the Chairman of the Audit Committee of the Company and a member of the Remuneration Committee of the Company. She holds a Bachelor Degree in Accounting and Financial Management from Loughborough University of Technology, England. She is a Certified Public Accountant (Practising) of The Hong Kong Institute of Certified Public Accountants and a fellow member of The Association of Chartered Certified Accountants. Ms. Wong has over 20 years' experience in auditing and business advisory. She also has experience in the IPOs of various companies and has been providing financial advisory services to listed companies in relation to accounting, internal control and financial matters.

Ms. Wong does not hold any directorship in any other listed companies in the last three years. She does not have any relationship with any other substantial shareholder, director or senior management of the Company or any of its subsidiaries. As at the Latest Practicable Date, she does not have any interest in the Shares within the meaning of part XV of the SFO.

The term of office of Ms. Wong has been renewed for a term of one year up to 14 December 2014 and is subject to earlier determination or retirement by rotation and re-election at the AGM in accordance with the provisions of the Bye-Laws. There was no service contract entered into between the Company and Ms. Wong in the past years. At present, Ms. Wong is entitled to receive a fee of HK\$165,600 per annum, with reference to his experience, qualifications and duties to the Company.

Save for the matters disclosed above, there is no information that is required to be disclosed pursuant to Paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules, and there are no other matters that need to be brought to the Shareholders' attention regarding her election.

**Mr. Wong Kui Fai**, aged 57, is an independent non-executive Director. He is presently the Chairman of the Nomination Committee of the Company and members of both the Audit Committee and Remuneration Committee of the Company. He holds a Bachelor Degree in Actuarial Science from University of Kent at Canterbury, England. He has been in the information technology ("IT") field for over 20 years with regional exposure covering the Greater China region and the United States. He had served at senior management levels for a number of multinational e-commerce solutions corporations and IT investment companies with hands-on experience in operation, strategic planning and direct investment. Mr. Wong formerly was the General Manager of Microsoft Hong Kong Limited and is presently actively engaged in mergers and acquisitions of cross border IT investment projects.

Mr. Wong does not hold any directorship in any other listed companies in the last three years. He does not have any relationship with any other substantial shareholder, director or senior management of the Company or any of its subsidiaries. As at the Latest Practicable Date, he does not have any interest in the Shares within the meaning of part XV of the SFO.

The term of office of Mr. Wong has been renewed for a term of one year up to 30 November 2014 and is subject to earlier determination or retirement by rotation and re-election at the AGM in accordance with the provisions of the Bye-Laws. There was no service contract entered into between the Company and Mr. Wong in the past years. At present, Mr. Wong is entitled to receive a fee of HK\$165,600 per annum, with reference to his experience, qualifications and duties to the Company.

Save for the matters disclosed above, there is no information that is required to be disclosed pursuant to Paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules, and there are no other matters that need to be brought to the Shareholders' attention regarding his election.

## **SHARE CAPITAL**

As at the Latest Practicable Date, there were 151,404,130 Shares in issue.

On the assumption that there will be no variation in the issued Shares prior to the date of the AGM, the Company would be allowed to repurchase up to a maximum of 15,140,413 Shares.

## **REASONS FOR THE REPURCHASE**

The Directors believe that it is in the interests of the Company and its Shareholders to have general authority from the Shareholders to enable the Directors to repurchase Shares on the Stock Exchange. Such repurchase may, depending on marketing conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchase will benefit the Company and its Shareholders as a whole.

## **FUNDING OF THE REPURCHASE**

It is proposed that the repurchase of Shares under the Repurchase Mandate would be financed from available cash flow or working capital facilities of the Company and its subsidiaries. In repurchasing the Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum, Bye-Laws and the laws of Bermuda. The laws of Bermuda provide that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant Shares, or funds of the Company which would otherwise be available for dividend or distribution or the proceeds of a new issue of Shares made for the purpose of the repurchase. The amount of premium payable on the repurchase may only be paid out of either funds of the Company which would otherwise be available for dividend or distribution or out of the share premium account before the Shares are repurchased.

On the basis of the consolidated financial position of the Company as at 31 December 2013 (being the date at which the latest published audited financial statements of the Company have been made up), the Directors consider that the exercise in full of the Repurchase Mandate to repurchase the Shares might have a material adverse impact on the working capital or gearing position of the Company as compared with its position as at 31 December 2013. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing level of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

**DISCLOSURE OF INTERESTS**

None of the Directors nor, to the best of their knowledge and having made all reasonable enquiries, any of their associates has any present intention, in the event that the Repurchase Mandate is approved by the Shareholders, to sell any of the Shares to the Company.

No connected person (as defined in the Listing Rules) has notified that he/she has a present intention to sell any of the Shares to the Company, or has undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

**UNDERTAKING OF THE DIRECTORS**

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchase pursuant to the proposed resolution in accordance with the Listing Rules and the laws of Bermuda.

**EFFECT OF THE TAKEOVERS CODE**

If as a result of a repurchase, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of Rule 32 of the Takeovers Code. Accordingly, if such increase results in a change of control, a Shareholder or a group of Shareholders acting in concert may in certain circumstances give rise to an obligation to make a mandatory offer in accordance with Rules 26 and 36 of the Takeovers Code.

As at the Latest Practicable Date, based on the registers required to be kept by the Company under Section 336 of the SFO and so far as is known to the Directors, no Shareholder would be required to make a mandatory offer under Rule 26 of the Takeovers Code in the event that the Directors shall exercise the Repurchase Mandate in full and assuming there is no change in the issued share capital of the Company from the Latest Practicable Date and up to the date of passing of relevant resolution granting the Repurchase Mandate.

Assuming that there is no further issue of Shares between the Latest Practicable Date and date of repurchase, the exercise of Repurchase Mandate whether in whole or in part will not result in the number of Shares being held by the public as required by Rule 8.08 of the Listing Rules being reduced to less than 25% of the issued share capital of the Company. The Directors have no intention to exercise the Repurchase Mandate to an extent as may result in a public shareholding of less than such prescribed percentage.
