deed dated 7 June 2017) (the "Amendment"). The Amendment was approved by the independent snareholders.
of the Company at the special general meeting of the Company held on 27 July 2017. On 20 April 2020, the
maturity date of the Convertible Notes was automatically extended to 20 April 2024.
